(2) They shall come into force on the date of their publication in the Official Gazette.

2. **Method of recruitment and qualification** : Notwithstanding anything contained in any other rules and orders regulating the recruitment to the post of **Cashier** in the Department of Sports and Youth Services, Sports Wing, Government of West Bengal, the method of recruitment to the post and qualifications required shall be as detailed below :

(A) **By direct recruitment.**

(B) **Qualification** :

(a) **Essential** : (i) Bachelor's Degree preferably in Commerce from a recognised University with at least one one year's experience as a Cashier in a Firm of repute.

(ii) Must be a citizen of India.

(b) **Desirable** : Knowledge of Bengali, English, Hindi—Spoken and Written.

(c) **Age** : Not below 18 years and not above 30 years on the date of issue of Notification for such recruitment (provided that the West Bengal Service Raising of age limit) Rules, 1981, shall apply.
