The Secretary, Department of Sports inquired about the progress of different sports infrastructures executing by the P.W.D., K.I.T., M.B.L. and the W.S.F.L. The Chief Engineers and the M.D./ G.M.s submitted the updated status of those public works.

After detailed discussion, following points were resolved:

- I. **Swimming Pool at Baruipur Municipality**: Chief Engineer, P.W. (Electrical)- I will cause for submitting vetted estimate of electrical works within a week.
- II. The Chief Engineer, P.W.D. was requested to expedite submitting vetted estimates for construction of new stadia at Islampur in Uttar Dinajpur district; Mogra in Hooghly district; Buniadpur in Dakshin Dinajpur district; vetted estimate for indoor stadium at Balurghat in Dakshin Dinajpur district and Dumrjola in Howrah district.
- III. Rabindra Sarobar Stadium: Work order for sewerage and drainage system issued by the K.I.T. Work will be started after monsoon. Tender for ground improvement did not mature. K.I.T. will relax some tender criteria and will publish next call within a week. Estimate for two dressing rooms will be submitted to the Department of Sports. A joint visit will be held on 18.08.2014 at 3.30 pm at the site to review the progress of

- remaining works. Chief Engineer, K.I.T. will submit the bar chart for project completion during the site visit.
- IV. Kishorbharati Stadium: Drainage works will be completed by the end of September. 2014. Field development will be done by the end of this calendar year. Target for completion of public toilets, internal roads also fixed at December, 2014. General Manager, M.B.L. will submit a bar chart showing the project completion period to the Department of Sports within a week .They will also submit original plan and drawing of club house, ground floor of the stadium and the present condition of the occupants. M.B.L. will also submit the U.C. immediately for release next installment.
- ٧. Subhas Sarobar Swimming Pool: W.S.F.L. will complete all works within 15th October, 2014 in order to host the National Swimming Competition from 5th to 9th November. 2014. Renovation works is at the last stage and the electrical works will be completed by 7 days. A joint visit will be held during 1st week of October, 2014. M.D., W.S.F.L. will submit a revised claim in terms of the latest G.O. of the F.D.
- VI. Vivekananda Yuba Bharati Krirangan: Chief Engineer, P.W. (Electrical)-I will arrange for a thorough checking of electrical works of the stadium and will submit their observation to the C.E.O., V.Y.B.K..
- VII. Diamond Harbor Stadium: Chief Engineer, P.W. (Electrical)-I will arrange for submitting vetted estimate of electrical works within a week.
- VIII. Barrackpur Stadium: Chief Engineer, P.W. Dte., South Zone will arrange for immediate tender and starting of works.
- Naihati Stadium: Chief Engineer, P.W. Dte., South Zone will arrange for immediate IX. tender and starting of works.
