ORDER

Permission to enter or remain within the swimming pool will be determined by the following rules and regulations:

By obtaining a valid Card, a swimmer thereby will consent to the rules and regulations outlined by the Government of West Bengal in the Department of Youth Services and Sports.

Swimmers must comply with the following rules, bans and warnings:

CARD RULES

1. The Card is assigned to an individual person and is non-transferable.
2. The Card must be kept and showed upon request, until the end of the swimming and until departure from the swimming pool.
3. Obtaining a Card does not authorise any individual to enter into the swimming pool along with any companion.
4. Instructions verbally or written issued by the Coaches/ Life Savers shall strictly be followed.
4. Swimmers may be subjected to security checks by Security Guards and also by metal detectors in order to ensure that no illegal, banned or dangerous materials are brought into the swimming pool. By obtaining a valid Card to the swimming pool, Swimmers acknowledge the right of the on duty security personnel to search any individual, clothing and other items in their possession, without exception.
6. The Authority reserves the right to debar from using the Swimming Pool in future to any individual, who fails to comply with any of the outlined Swimming Pool Rules and Regulations.

PROHIBITORY CONDUCTS

7. The following behaviour is strictly forbidden inside Pool:
 - a. Smoking within the swimming pool complex.



b. Passing urine in the pool or spitting or blowing your nose or otherwise contaminating water in any way inside the swimming pool.

c. Use of foul or abusive or provoking language, chanting, harassment or the showing of offensive written banners of a racial, homophobic or religious nature, which may offend the sentiment of others;

d. Swimming by any person when he is ill or having infectious and high risk diseases or having disease which can endanger others life in water such as:- a) Hysteria, b) Epilepsy, c) High Blood Pressure, d) Severe Diabetes, e) Severe Pulmonary Tuberculosis;

e. Damage to, tampering or interfering with any structure, infrastructure, equipment, furniture, fitting or fixture within the swimming pool;

f. Bringing in or possessing harmful substances, inflammable substances, dyes or drugs;

g. Bringing in or selling alcoholic drinks/ drugs;

h. Bringing in or possessing fireworks;

i. Bringing in or possessing stones, knives, bottles, glass containers, noise emitters, laser devices or any other objects which could be thrown or could somehow compromise public safety;

j. Bringing in or selling drinks contained in cans, glass or plastic bottles;

k. Attempting to enter the swimming pool or be inside the swimming pool whilst drunk or under the influence of drugs.


l. Getting inside the water without the permission of Coach/ Life Saver

m. Swimming during storm, rain or lightning

WARNINGS


It is an offence to:
